The Customer hereby indemnifies and holds the Company harmless from and against any loss, claim, action, damage, fine, cost or expense suffered or sustained by the Company, its clients, or any third party pursuant to the Customs authorities holding the Company liable in terms of the customs guarantee as a result of the Customer, or a third party haulier and/or agent or reprensentative's act or omission.

- 8. The Customer is responsible for proving that the goods in transit have crossed the border. Should any queries be directed to the Company the Customer undertakes to disclose all information to the Company in an efficient manner and assist with all investigations held by the Company and/or the customs authorities.
- 9. In the event that a fine, investigation, payment or deduction is made against the Company's guarantee in respect of a Customer's cargo the Company will be entitled to raise an invoice to the Customer in respect of all charges incurred. The Company will **not** deal with the third party Haulier.
- 10. The Company reserves the right to raise an additional 10% administration fee over and above the fine and/or additional costs incurred.
